Object: Environmental labelling.

Dear Customer,

On 30 December 2021, Decree Law No 228 of 30 December 2021, the so-called "Milleproroghe" Decree Law, was published in the Official Gazette.

Article 11 of the measure provides for the suspension of the environmental labelling obligation for packaging until 30 June 2022, as well as the possibility for operators in the sector to market products not complying with the new environmental labelling requirements which have already been placed on the market or which already have a label on 1 July 2022, while stocks last.

The provision also foresees the issuing of a non-regulatory decree signed by the Minister for Ecological Transition for the adoption of technical guidelines for the correct labelling of packaging.

Given that goods already placed on the market before 30 June 2022 are not subject to mandatory labelling, we will only be liable for all those products placed on the market after that date and which we will not deliver to you unless they are re-processed and correctly re-labelled.

In this respect, a note dated 17 May 2021 from the Ministry of Ecological Transition clarified that, where there are actual physical and/or technological limitations to physically affixing environmental labelling to packaging, this information can be conveyed through digital channels¹ or, where this route is not possible either, it must be made available through the company's and/or retailer's websites.

To this end, all our transport documents and accompanying invoices will be marked with the words "Environmental marking of packaging available at www.inoxmare.it"¹ where a page has been set up containing all the correct instructions on how to dispose of each package.

The aim is to give a clear indication to all our customers until all packaging complies with the new regulations.
